Promotion Terms & Conditions

1. The “**Goodyear Summer Promotion 2020**” (the “Promotion”) is open to all consumers who are UK residents aged 18 and over except employees of Goodyear Tyres UK Limited (the “Promoter”) and its agencies or anyone else connected with the creation and administration of the promotion.
2. The promotion is only and exclusively available at Approved Participating Retailers within the qualifying promotional period (15th June 2020 – 15th August 2020) Approved participating retailers are listed on https://www.goodyear.eu/en_gb/consumer/offers-hub from 15th June 2020 until 15th September 2020 (*final redemption/claim date*)
3. There is a purchase requirement. The offer is open to retail customers who purchase qualifying Goodyear tyres (two or more Goodyear car, van, 4x4 or SUV tyres with rim size of 17” inch or above for a single vehicle).
4. The offer excludes company vehicle drivers (Fleet), businesses, organisations and institutions.
